Participants Agreement, Release and Acknowledgement of Risk

In consideration of the of the services of Gaston Lions Club the agents, owners, officers, volunteers, participants, employees and all other person or entities acting in capacity in their behalf. I hereby agree to release and discharge Gaston Lions Club, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estates as follows.

1. I acknowledge that Gaston Lions Club entail known and unanticipated risks which could result in physical or emotional injury, Paralysis, death or damage to myself, to property or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: Collision with others, the walls or other fixed objects, falling down: my own equipment failure or the failure of other's equipment: my own or others negligence: objects or conditions on the surfaces that may cause me to fall: broken bones, sprains, head and back injuries, abrasions and bruises. Furthermore, Gaston Lions Club has difficult jobs to perform. They will seek safety but are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions and the equipment being used might malfunction.
2. I expressly agree and promise to accept and assume all the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge and agree to indemnify and hold harmless Gaston Lions Club and all claims, demands or causes of action, which are in any way connected with my participation in this activity or my use of their equipment or facilities, including such claims which **allege negligent acts or omissions of the Gaston Lions Club**.
4. Should Gaston Lions Club or anyone acting on their behalf be required to incur attorney's fees and cost to enforce this agreement, I agree to indemnify and hold harmless for al such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I my cause or suffer while participation, or else I agree to bear the costs of such injury or damage to myself, I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created directly or indirectly by any such condition.
6. In the event that I file a lawsuit against the Gaston Lions Club, I agree to do so solely in the state of Indiana and I further agree that the substantive law of that state shall apply in this action without regard to the conflict of law rules of that state.
7. I agree that if any portion of this agreement is found to be void or unenforceable the remaining portion shall remain in full force and effect.
